# **FerryLive: Privacy Policy**

**Grumsen Development ApS** ("we," "us," or "our") respects the privacy of our users ("user" or "you"). This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you use our mobile application, **FerryLive**. Please read this Privacy Policy carefully. **If you do not agree with the terms of this Privacy Policy**, **please do not access the application**.

This policy applies to all information collected or submitted through the FerryLive app and any associated devices or platforms.

## 1. Where is my FerryLive data stored?

All data in the FerryLive app is **private** and stored **only on your mobile device**. We do **not** store or process your data on our servers.

Data in FerryLive may also be automatically saved in **Apple's iCloud** as part of your device's iCloud backup if enabled and there is enough space available in your iCloud account.

There are **no user accounts** required to use FerryLive.

## 2. Information collected about your use

We may collect certain **non-personally identifiable information** about your usage of FerryLive, such as:

- Frequency and duration of app use
- Significant events within the app
- Errors or crashes

This information may include general device details (e.g., model, OS version) and is shared with third-party **analytics and crash reporting services** to help us understand app usage, detect issues early, and improve the FerryLive experience.

You can **opt out** of sharing this information via the app under **Settings**  $\rightarrow$  **Privacy**.

## 3. Advertisements and In-App Purchases

FerryLive contains **advertisements** and offers **In-App Purchases** to support the app. We may use third-party libraries for ads and analytics, which may collect and share personal information with their partners.

Privacy policies of third-party services used in the app include:

## 4. Cookies and website tracking

When visiting the **FerryLive website**, small files called **cookies** may be stored on your device to collect anonymous analytics about website usage. Your IP address is anonymized, and these cookies are **not used to identify you personally**.

You may opt out of analytics cookies at any time.

#### 5. Push Notifications

We may request permission to send **push notifications** about the app or important updates. You can opt out of receiving notifications in your device settings.

#### 6. Security

We prioritize the security of your data, but **no method of transmission or storage is completely secure**. While we use commercially reasonable measures to protect your information, we **cannot guarantee absolute security**.

#### 7. Changes and Updates

We may update this Privacy Policy or our Terms and Conditions from time to time. Updates will be posted in a timely manner, and we recommend reviewing the policy regularly, especially after app updates.

In the event of a business transaction, such as a sale or merger involving FerryLive, we may transfer your information as described in this policy.
